How to interpret your contract: The total number of skaters contracted for each session is provided. This will help you determine which sessions you might want to add onto. The number of skaters on the ice will not exceed 22. Thus, if there are more skaters listed than 22, the remainder will be on the waiting list.

The “Contracted sessions” column will have an X in the box for the session for which you have been contracted. If you are on the waiting list for that session, there will be a W followed by a number indicating which number on the waiting list you would be.
